Network AID Africa Fundraising Policy

2026

A. Introduction

Network AID Africa is a voluntary human right not-for-profit making non-political organisation founded on the 16th June 2013 that seeks to contribute to national and international agenda of empowering illiterate women and deprived children in society to realize their full potential irrespective of religion, ethnic background, tribes and cultural heritage. It believes in the fundamental principles of human rights, independent/neutral, volunteerism, professionalism, inclusion, respect, accountability and transparency. Network AID Africa discourage all forms of social pressure, discriminations and social exclusion against illiterate women, girls, persons with disability, youth and deprived children. receive and file complaint of human rights abuse and violation against illiterate women and deprive children; provides training and awareness raising on corruption, gender base violence, children's rights; HIV/AIDS; mental health, cancer; water, sanitation and hygiene (WASH) and information communication technology; harmful traditional practices; facilitate dialogue among key interest groups for the voice of illiterate women, girls, persons with disability, youth and deprived children to be heard and acted upon; conduct research/survey and advocate on issues that affect the well-being and development.

B. Vision

The vision of Network AID Africa shall be “An inform society that recognize illiterate women and girls, young people, persons with disability and deprive children for a sustainable, corrupt free, and healthy population”.

C. Mission

The ultimate mission of Network AID Africa shall be “Enhancing the well-being and well-welfare of illiterate women and girls, young people, persons with disability and deprive children development and participation for a healthy, productive and corrupt free society”

D. Use of Donation

Donations made to the organization are tax deductible to the fullest extent of the law as applicable. All donations solicited on behalf of Network AID Africa shall be used to further the organisation mission and vision, activities and values. Network AID Africa will ensure all donations (Cash, In-kind, Tool, or Equipment) are use of it intended purposes and reach the actual beneficiaries. Donation can also be used for the administrative, legal counsel, operational cost of the organisation this cost shall not exceed 20%.

E. Donation Accountability

1. All donations and gift shall be recorded in a donation and gift diary with the name, telephone number, email address, donation type and amount equivalent. Donation and gift receipt shall be provided to the donor with a thank you and appreciation letter. Donation or gift received anonymously shall be recorded accordingly with acknowledgement.
2. All donations and gift will be accounted for and reported in the annual financial and liability report and published online.
3. All donations and gift received will be published publicly via the organisation communication channels.

F. Definition of Gift and Donor

This Fundraising Policy addresses gifts made to Network AID Africa by donors. A “gift” is a donation of money or anything of value to Network AID Africa. ([gift policy](#)) A “donor” is an individual, foundation, club, corporation, multilateral, or other business entity that makes a gift to Network AID Africa.

Network AID Africa seeks gifts and future gift commitments that are consistent with our mission, vision and values. Donations/gift generally will be accepted from individuals, philanthropists, foundations, grant



makers, partnerships, corporations, organizations, government agencies or other entities without limitations — unless acceptance of gifts from a specific source is inconsistent with our mission, vision and values. Our policies and procedures are described below: -

G. Fundraising Policies and Procedures

1. All fundraising activity/event must comply with applicable local, state or federal laws and regulations.
2. Network AID Africa reserves the right to refuse or return any gift that is not consistent with its mission, vision and values or that could introduce a conflict of interest. Furthermore, gifts will be accepted only when:
 - a) Undue influence would not be exerted by the donor to shape the spending of Network AID Africa nor to distort the programs of Network AID Africa (i.e., a gift must not compromise Network AID Africa's mission, vision, values or advocacy); and
 - b) The gift does not endanger the public's trust in Network AID Africa to advocate for illiterate women/girls, youths, persons with disability and deprived children. For example, Network AID Africa will not accept gifts from donors who engage in practices that are unusually damaging to the environment or companies with significant violations of human rights within the last two years.
3. Network AID Africa will acknowledge all gifts within no more than 30 days of receipt. Donations of \$1,000 or more will also receive a personal phone call from an employee or technical advisory team member.
4. Any information supplied to Network AID Africa shall not be shared for any reason unless the donor grants permission.
5. Network AID Africa does not sell or share donor lists.
6. This policy shall be in consistent with other policies of Network AID Africa such as Confidentiality Policy, Data Protection Policy.
